# Information about International Driving Permits (IDP)

### What is an International Driving Permit?

An International Driving Permit is a document issued in accordance with regulations found in various international conventions on road traffic. It serves as a translation of a national driving license into several "foreign languages".

The current applicable international road traffic conventions are the 1949 Geneva Convention (valid for 1 year) and the 1968 Vienna Convention (valid for 3 years).

#### When do I need an International Driving Permit?

It depends on which country or countries you plan to visit. You do not need an IDP if you are visiting EU countries and have a Swedish driving license of the new EU model.

Even if an International Driving Permit is not mandatory for private travel in all countries, it can often be beneficial to have one with you on your trip, as it serves as a translation of the Swedish driving license in case of checks.

If you intend to drive a rented or borrowed vehicle registered in the country you are visiting, it is always recommended to have an International Driving Permit.

#### 3 Years or 1 Year?

International Driving Permits (IDP) are issued according to two different international road traffic conventions:

- » IDP under the 1949 Convention is issued to be valid for one year.
- » IDP under the 1968 Convention can be issued to be valid as long as the Swedish driving license is valid, but for a maximum of three years.

Some countries accept both versions, while others only accept one. Depending on which countries you plan to visit, MHF issues the appropriate International Driving Permit.

You can see which convention applies in the country you are visiting by checking the table on our website mhf.se/ikk/international-driving-license/.

#### **Rules for IDP**

- » The minimum age to obtain an International Driving Permit is 18 years.
- » The Swedish driving license must always be carried during the trip.
- » An International Driving Permit is not valid in the country where the holder is resident. For professional traffic, professional activities, and residency, special regulations apply.
- » IDP is not valid for travel in Sweden, Norway, Denmark, and Finland.
